Technical Observations

- The market sentiment continued to favor the bears as weakness persisted across technical and momentum indicators, even as the Nifty managed to hold above 24,600 for the third consecutive session. On the daily chart, the Nifty 50 formed a bearish candlestick with small upper and lower shadows, reflecting choppy trading action.
- The index extended its sequence of lower tops and lower bottoms for the eighth straight day, with both short- and medium-term moving averages trending downward. Notably, the 10-day EMA slipped below the 20-day and 50-day EMAs. The RSI weakened to 38.13, while the MACD moved below the zero line with a negative crossover. Additionally, the MACD histogram signaled further downside pressure, reaffirming the prevailing bearish trend.
- Looking at the levels, It appears that 24843 is performing as a significant resistance level for the Nifty. On the higher side, though, 24716/24733/24788 levels will act as a resistance area for the NIFTY. If we look at the lower side, support is located at 24571/24554/24499 and 24444 levels.

Technical Observations

- ➤ The Bank Nifty extended its gains for the second consecutive session, advancing by 175 points on the monthly F&O expiry day. On the daily chart, the index formed a bearish candlestick with upper and lower shadows, resembling a high-wave pattern—signaling heightened volatility and ongoing indecision between bulls and bears.
- Despite the recovery, the index remains well below the 20-, 50-, and 100-day EMAs, with the 10-day EMA trading beneath all three. Moreover, the 20-day EMA is on the verge of slipping below the 100-day EMA, underscoring continued weakness. The RSI improved marginally to 45.14 but still reflects a bearish crossover, while the MACD also remains in a bearish crossover with further deterioration in the histogram.
- ➢ Overall, Bank Nifty continues to trade in a corrective phase, with prior swing lows still intact, and the near-term trajectory will hinge on its response to key support and resistance levels. In terms of levels, resistance is anticipated at 54789/54823 levels. Should a breakout occur at 54934, it could signify additional buying interest, potentially leading to the 55045 level. Crucial support for the index is expected at 54499/54465/54354 and 54243 levels.


